Writing to Texts

The balance of student writing at this level is **80 percent analytical** (40 percent argument and 40 percent to explain/inform) and **20 percent narrative**, with a mix of on-demand and review-and-revision writing assignments. Building student competence and confidence with technology should be part of instruction.

Research

This module includes the opportunity for students to produce **one extended research task** that uses research to address a significant topic, problem, or issue. This task should entail integrating knowledge from several additional literary or information texts in various media or formats on a particular topic or question drawn from one or more texts from the module.

Students are expected at this stage to:

assess the usefulness of each source, refocus their research during the process and integrate the information gathered in a manner that maintains the flow of ideas.

Students can present their findings:

in a variety of modes in informal and more formal argumentative or explanatory contexts, either in writing or orally.

(Research aligned with the standards could take one to two weeks of instruction.)

Ongoing incorporation of research for shorter tasks should also be a regular component of instruction.
